Intergovernmental Committee Meeting

- I. The meeting was called to order at 6:00 p.m.
- II. **Roll Call:** Present were Trustees Doug Marecek, Steve Jungermann and Denny Lee, Pete Wallers, Armando Sanders, Dan Meyers, Todd Hoppenstedt, Mark Wolf, Penny FitzPatrick, Debbie Buchanan, and members of the press. Trustees Stan Bond and Pete Heinz arrived at 6:25 p.m.
- III. **Minutes:** This item was postponed until a quorum was present. Steve Jungermann moved to approve the minutes of October 23, 2017, seconded by Denny Lee. Motion carried 4-0. Pete Heinz abstained.
Doug Marecek moved to approve the minutes of January 22, 2018, seconded by Stan Bond. Motion carried 4-0. Pete Heinz abstained.
Steve Jungermann moved to approve the minutes of February 26, 2018, seconded by Stan Bond. Motion carried 4-0. Pete Heinz abstained.
- IV. **Items for Discussion**
 - A. Sunday in the Park—Doug Marecek reviewed plans for this event. EEI has offered to sponsor the free ice cream again this year. Chief Meyers is arranging for the SWAT vehicle and the Kendall County Mounted Police. The band is lined up and the Park District will provide portalets. Debbie will contact Grumpy Gaucho, the hot dog vendor and the ice cream vendor. She is also to work on a flyer for Sunday in the Park, and also a handout for Montgomery Fest that can be distributed at the Sunday in the Park event.
 - B. Montgomery Fest
 1. Bands—Steve Jungermann shared audio clips from the Tin Fiddle Band and the committee agreed to offer them one of the daytime entertainment slots. Debbie is to follow up with Woody James, Mr. Freeze and Sci Tech to book them.
 2. Shuttle bus and stops—The committee agreed this will be the same as last year.
 3. Beer Tent—It was decided that the Montgomery Foundation will pay a vendor fee of \$1400 and will pay for police officers at their booth.
 4. Golf Carts—Todd already has these reserved.
 5. BMX Stunt Show—There has been no response yet.

6. Handicap Parking—This depends on who the new owner of the Mill Tavern property is. The Police will work on this.

7. Grand Marshal—Denny Lee will talk to the potential Grand Marshal.

8. Montgomery Fest Brochure—May want to print in color this year.

Other items: the applications for craft booths have been mailed out. Sponsorship information will be mailed out around April 1st. The Talent Show flyer is posted online and the tryouts are scheduled for July 14th.

Due to the construction at Austin Park, there will be no restrooms there for Montgomery Fest. Denny will talk to FVPD to get free portalets, at least 1 handicap and 2 standard. If not, we will need to rent those.
