May 23, 2022*

I. Trustee Betsinger called the meeting to order at 6:30P.

Also present: Village Engineer Pete Wallers, Communications Manager Kristina Nemetz, Chief of Police Phil Smith, Village Administrator Jeff Zoepfel, and Director of Public Works Mark Wolf.

III. Public Comment NONE.

IV. Minutes of April 25, 2022: Trustee Marecek moved to approve the minutes of the April 25, 2022, Intergovernmental Minutes. Trustee Jungermann seconded this motion. Motion carried 5-0.

V. Items for Discussion

- Communications Manager Nemetz reviewed the Montgomery Street Eats Fest Details with the Committee. Details shared included the scope and the layout of the event. Nemetz encouraged the Trustees to attend the event on June 4 from 11A-7P.
- Gray's Mill is hosting a spring German Fest the same weekend, June 2-5.
- Atrevete Confections will be open during the Street Eats Fest and Grumpy Gaucho will be participating in the event after they are done at the Naperville Farmers Marketing (After 1-2P).

- Trustee Betsinger asked when the homeowner letters were going out to the homes located along River St. Staff confirmed letters will go out from the Police Department.
- Trustee Jungermann asked if Concerts in the Park were still taking place in Montgomery Park. Staff responded that there were no concerts planned by the Fox Valley Park District for this summer nor on behalf of the Village for 2022.
- River Run will take place on October 1, 2022. The staff from the Village and EEI will work together this year on the event with the goal to transition the planning of the event eventually to the Village. Staff will continue to keep the Board updated on the transition process and partnership for the event. EEI has planned and coordinated the River Run for 19 years.
- Trustee Betsinger asked what registration software the run plans to use for race registration. Staff indicated Race Roster will be used again.
- Trustee Gier recapped the Arbor Day event. Approximately 40 people were in attendance and the 2022 tree, the White Fringe, is now blooming near the silo at the police department. The event was successful and the committee would like to explore doing something similar with a tree giveaway again in 2023.
- Trustee Gier also indicated that the Rotary plans to purchase benches without sides, hopefully less likely to be damaged for the park.
- Trustee Marecek updated the Committee on the status of planning the Montgomery Fest. Current sponsorship as of May 18 is \$17,600. Food vendors confirmed currently is 3. The committee is working on several areas of the fest.
- Trustee Marecek noted that the carnival will not begin on Saturday or Sunday until noon, which is one hour later than with the previous carnival vendor.
- There will be no ice sold at the fest this year by a community organization as Rotarty has declined participation for 2022. Staff will work with local businesses to offer/suggest ice sales locations to vendors for their convenience.
- As of right now only sponsor booths will be offered along River St. Staff is exploring a craft show opportunity that would take place closer to Village Hall as the Historic Preservation Commission declined taking over this portion of the fest.
- Trustee Marecek shared that the committee is exploring expanding shuttle service to include Friday evening as well to better assist with parking in the downtown area.
- The Car Show will take place on Saturday instead of Sunday in 2022. The Historic Preservation Commission is exploring a partnership with 110 Customs in Montgomery on Aucutt Rd. The hours of the car show will be later in the day vs in years past. The show will begin around 11A and will be completed at some point between 6 and 7P.

- Trustee Betsinger requested to table the Rotary Raffle Request on the agenda since Trustee Sperling and Village President Brolley were not in attendance. The discussion was tabled and post-poned to a future meeting/discussion.
- Communication Manager Nemetz shared that the next meeting would be primarily focused on Montgomery Fest during which the Committee/Staff will present information and details of the Fest final plans.
